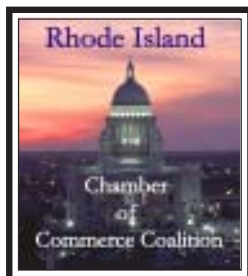

The Chamber Coalition is the largest business advocacy organization in Rhode Island.



The East Providence Area Chamber of Commerce was admitted into the Rhode Island Chamber of Commerce Coalition in January 2007. The Chamber of Commerce Coalition is an expansion of a lobbying partnership begun in 1996.

The Coalition was formed as many Rhode Island chambers of commerce recognized that Rhode Island needed an advocate at the State House to speak for the interests of business. While laws impact both large and small companies, most business owners and managers do not have time to attend committee hearings and offer testimony on proposed legislation. By having their chambers of commerce act as their voice, company officials can easily have a say in the business of government. By unifying chambers throughout the state, the voice of business becomes louder and stronger.

Growing in strength and numbers since 1996, The Coalition represents ten chambers of commerce and more than 6,500 businesses. Through its online activity, www.RIBusinessVotes.com, chamber members are kept well-informed of pending legislation that may affect their businesses. They are also able to easily and quickly contact their legislators via this Web site.

The Government Affairs Committee establishes the Coalition's annual legislative agenda and it is ratified by the respective chambers of commerce members one month prior to the start of a new legislative session.

**History of the
East Providence Area Chamber of Commerce**

The East Providence Area Chamber of Commerce was founded and incorporated in 1897 as the Riverside Businessman's Association. It was created for the purpose of social, literary and educational relations among its members. The Chamber is a 501(c)6 non-profit, membership-based organization.

In 1956, the name was changed to East Providence Chamber of Commerce. In 2005, the board of directors voted and officially changed the name once more to East Providence Area Chamber of Commerce to better reflect the communities that the Chamber now serves.

In 2007, the Chamber celebrated its 110th anniversary and also became a partner of the Rhode Island Chamber of Commerce Coalition. "The Coalition" is comprised of ten Rhode Island Chambers of Commerce and represents more than 6,500 businesses.

The East Providence Area Chamber of Commerce recognizes that the business community is continually expanding into a global community. We strive to assist all of our members involved in the local, national and world-wide markets. However, we have not lost sight of the companies whose businesses are predominately in our local community. The Chamber recognizes and continues it's mission to be a proactive advocate for local businesses, in addition to our expanding state-wide efforts on behalf of our members.

What is a Chamber of Commerce?

A chamber of commerce is a voluntary partnership of business people working together to build a healthy economy and improving the quality of life in the community in which they work and/or live.

Chambers of commerce are run by their members. The board of directors is elected by the membership and their role is to determine the policies and goals of their chamber. The board chair presides over board meetings and the chamber's executive director/president oversees and coordinates the day-to-day operations and activities of the chamber office.

In order to accomplish the goals set by the board of directors, a chamber of commerce serves as:

- economic developer & planner
- business spokesperson
- government relations specialist
- public relations practitioner
- tourist information center
- economic counselor & teacher
- human resources advisor
- local phone directory operator

Each of these roles are accomplished through the active participation of the chamber's members, volunteers and staff.

Chamber committees serve a vital role in the success of a chamber. Committee focus varies from one chamber to another. They depend upon the area in which the chamber resides; as well as the chamber's goals as determined by the board (membership.)

Chamber membership provides numerous opportunities for businesspeople to develop contacts and promote their products and services. Individuals determine how active they want to be with their membership. Employees of member businesses are welcome to serve on East Providence Area Chamber of Commerce committees and attend events.

Annual membership dues are essential to supporting the multitude of services provided by the chamber. The revenue from membership dues enables the chamber staff to carry out the goals of the membership.

Chamber events and other activities are used to provide additional means of promoting and supporting the work of a chamber of commerce. They also provide visibility for member companies through their sponsorships of these events.

Health and Dental Insurance - Access to qualified consultants who assist our members, at no charge, with selecting the best health care plans for themselves and their employees based on their needs and budget.

Member2Member Discounts- Product and service discounts offered to and from our members through the EPACC *Member2Member Discount Program*.

Free Subscriptions - A free subscription to *Under The Dome*. A timely publication keeping our members informed about the progress of legislative bills that affect businesses.
